Giuliana Bruno is the Emmet Blakeney Gleason Professor of Visual and Environmental Studies at Harvard University. Her seminal work *Atlas of Emotion: Journeys in Art, Architecture, and Film* (2002) provided new directions for visual studies. In her new book, *Surface: Matters of Aesthetics, Materiality, and Media* (2014), she revisits the concept of materiality in the contemporary world. She has contributed to numerous monographs on artists including Chantal Akerman, Isaac Julien, Jesper Just, and Diana Thater.

Matthew Buckingham was born in Nevada, lowa, and currently lives in New York City. He studied at the Art Institute of Chicago, received a BA from the University of Iowa, an MFA from Bard College, and attended the Whitney Independent Study Program. Utilizing photography, film, video, audio, writing, and drawing, his work questions the role that social memory plays in contemporary life. Buckingham has had solo exhibitions at venues including the Brooklyn Museum (2011), Museo Nacional Centro de Arte Reina Sofía, Madrid (2009), Art Institute of Chicago (2008), and Hamburger Bahnhof, Berlin (2007).

Donna De Salvo is deputy director for international initiatives and senior curator at the Whitney Museum of American Art, New York, where she organized *Robert Irwin: Scrim veil—Black rectangle—Natural light, Whitney Museum of American Art, New York (1977)* in 2013, among many other major exhibitions. Prior to joining the Whitney in 2004, she was a senior curator at Tate Modern, London, and was a curator at Dia. De Salvo is currently preparing a retrospective of Andy Warhol's work to open at the Whitney in 2018.

Alva Noë is professor of philosophy at the University of California, Berkeley, where he is also a member of the Institute for Cognitive and Brain Sciences. Working across the disciplines of philosophy, cognitive sciences, and neuroscience, Noë has addressed the problem of perception and consciousness. Most recently he has focused on the nature of art and humans in *Strange Tools: Art and Human Nature* (2015).

Jeffrey Saletnik is assistant professor of art history and Germanic studies at Indiana University, Bloomington. His research on Bauhaus culture and pedagogy bridges interwar Europe and postwar America, concentrating on figures such as Josef Albers, John Cage, and László Moholy-Nagy. Saletnik has contributed essays to numerous journals and publications, most recently *Intersecting Colors: Josef Albers and His Contemporaries* (2015) and *Leap Before You Look: Black Mountain College* 1933–1957 (2015).

Matthew Simms is professor of art history at California State University, Long Beach. A specialist of modern European and American art, Simms is the author of the first scholarly monograph on Irwin, *Robert Irwin: A Conditional Art* (2016). He also edited and introduced the collected writings of Irwin, *Notes Toward a Conditional Art: The Collected Writings of Robert Irwin* (2011), and conducted an interview with the artist on behalf of the Archives of American Art (2013).
